### **Basic Functions:**

Plans, develops and implements an Adapted Physical Education Program for handicapped students requiring adapted physical education.

## **Representative Duties:**

- 1. Provides adapted physical education program to student with adapted P.E. written into their I.E.P.
- 2. Assesses physical motor needs of students and plans appropriate program.
- 3. Evaluates each student's gross motor progress based upon assessed potential in physical fitness and physical growth.
- 4. Establishes and maintains effective communication with parents, other teachers, support staff and school site administration.
- 5. Prepares and maintains a variety of records and reports as required by Federal, State and local mandates.
- 6. Serves as a member of the I. E. P. Team for adapted physical education students.
- 7. Provides training and serves as a resource for adapted physical education to other physical education teachers and special education staff.

#### **Knowledge and Skills Required:**

- Knowledge of guidelines and subject area in curriculum and instruction.
- Knowledge of the Physical Education Standards for special needs students.
- Knowledge of adaptive physical education techniques for special needs students.
