Basic Functions:

Provides an educational program for preschool aged students (3-5 years of age) that is developmentally appropriate, conducts herself/himself as a professional person, exhibiting the qualities of ability, personality and integrity that will make him/her respected by all those with whom he/she associates.

Representative Duties:

- 1. Instructs assigned students in groups or individually as required.
- 2. Utilizes ECE adopted curriculum guides as the primary source for age appropriate instruction and activities for the development of basic physical, emotional, academic and cognitive skills for preschool age students.
- 3. Evaluates student progress using state and federal standards and mandated and/or adopted assessment tools.
- 4. Modifies, prepares and plans instructional materials to meet the individual needs of the child.
- 5. Prepares written plans that clearly organize long and short range teaching and learning goals based on the state and federal standards and the needs of the child.
- 6. Submits lesson plans to ECE Coordinator monthly and as requested.
- 7. Establishes and maintains accepted standards of student behavior and conduct through an effective classroom management plan implementing positive reinforcement and strategies.
- 8. Creates and maintains a functional, organized, attractive and engaging classroom environment for children and ensures the cleanliness and safety of the facilities which meets the California Licensing Regulations.
- 9. Communicates appropriately with parents regarding student progress, needs and problems through consistent, open and effective home-school communications which would include home visits and school conferences as appropriate.
- 10. Prepares, files, administers, maintains, and reports student assessments as assigned.
- 11. Maintains suitable knowledge and skills through staff meetings, course work, in-service training, and professional growth activities.
- 12. Cooperates with other professional staff members.
- 13. Performs other professional duties as assigned, including but not limited to, student study team meetings, district committees, participation in parent involvement as appropriate.
- 14. Directs and supervises assigned support personnel such as child care assistants or para educators.
- 15. Sets personal example of appropriate dress, speech and professional conduct.

Knowledge and Skills Required:

Knowledge of:

- Guidelines and subject area curriculum and instruction.
- Principles, theories, practices, methods and techniques used in curriculum development, lesson planning and classroom instruction for early childhood education.
- Current trends and research concerning the growth and development of preschool children.
- Applicable sections of the State Education Code, District Policies and other applicable laws. Federal, State and District standardized assessment requirements.

Education and Experiences:

- Health Screening and Tuberculosis clearance.
- Must possess or have ability to obtain a valid California Driver's License or California Identification Card.

Physical Requirements and Working Conditions:
