Principal's Message

Abraham Lincoln Elementary School uses Leopard PRIDE, Perseverance, Respect, Integrity, Determination and Engagement to create a supportive, risk-taking environment. We combine the efforts of students, their families, our staff, and the Palm Desert community to support all children to achieve academic success.

Our staff uses district provided materials and strategies for reading, writing, math, science, and social studies. We have a full time Instructional Coach, who supports our classroom teachers with modeled lessons and professional development. We have a full time PE teacher and a full time Counselor to support our students' physical and social emotional needs. We use additional Title 1 and LCFF funds to offer during the day remediation and/or acceleration in reading and math.

Lincoln is an AVID Elementary School. The purpose of AVID is to foster students' individual determination to become college and career ready. We work on organizational skills, note taking, collaborating with peers, and planning for college and/or careers. Parents are asked to sign a calendar for grades TK-1 or an agenda for grades 2-5 every night.

Grade level teams meet each Wednesday to plan and implement the rigorous curriculum adopted by our District. Our School Site Council and English Advisory Committee helped the staff focus on the needs of the students and together we devised a plan to help Lincoln meet its academic goals.

We appreciate all of the parents and family members who have stepped up to help with learning at home, and be an advocate for their child, throughout this pandemic. The Lincoln staff works diligently to ensure all messages are translated for our Spanish speaking families. We ask parents to ensure their children are reading at home each day and to extend learning by helping their children apply what they have learned to real life experiences.

Our business partnerships include the City of Palm Desert, Palm Desert Rotary Club, Palm Desert Historical Society, McCallum Theater, as well as other Palm Desert businesses and retired citizens who donate time, money, and expertise in supporting our instructional program.

Students, staff, parents, and each member of this community work for continuous improvement and academic success. The involvement and support from all invested stakeholders is greatly appreciated.

School Description

Abraham Lincoln Elementary School is located in the central region of Palm Desert and serves students in grades transitional kindergarten through five following a traditional calendar. At the beginning of the 2022-23 school year, 585 students were enrolled, including 8.2% in special education, 34.7% qualifying for English Language Learner support, and 81.5% qualifying for free or reduced price lunch.

Student Achievement

Physical Fitness

In the spring of each year, Abraham Lincoln Elementary School is required by the state to administer a physical fitness test to all students in grade five. The physical fitness test (PFT) for students in California schools is the FITNESSGRAM. The main goal of the test is to help students in starting life-long habits of regular physical activity.

The FITNESSGRAM has six parts, though California currently requires five parts be completed annually, that show a level of fitness that offer a degree of defense against diseases that come from inactivity. The test results can be used by students, teachers, and parents. Comparative District and state results can be found at the CDE's web site www.cde.ca.gov/ta/tg/pf.

In the administration of the PFT during 2021-22 and 2022-23 school years, only participation results are required for these five fitness areas.

California Assessment of Student Performance and Progress

The California Assessment of Student Performance and Progress (CAASPP) System includes the Smarter Balanced Summative Assessments (SBAC) for students in the general education population, and the California Alternate Assessments (CAAs) for students with the most significant cognitive disabilities. Only eligible students may participate in the administration of the CAAs. CAAs items are aligned with alternative achievement standards, which are linked with the Common Core State Standards (CCSS). CAASPP results are a measure of how well students are mastering California's standards in English language arts/literacy (ELA) and mathematics, and are given to grades three through eight and grade eleven. SBAC tests assess student performance in ELA/Literacy and mathematics utilizing computer-adaptive tests and performance tasks, and CAAs test items are aligned with alternative achievement standards which are linked with the Common Core State Standards (CCSS).

The CAASPP results shown in this report include overall results comparing the school, district and state scores as well as the school's overall score in each applicable subgroup. Results are shown only for subgroups with ten students or more taking the exam. For those categories that are blank in the tables, no students met subgroup criteria. School Facilities & Maintenance

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Abraham Lincoln Elementary School's original facilities were built in 1964; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. In the last 12 months, the following campus repairs or improvements have been completed:

- Construction of 17 new classrooms including one set of new student restrooms, a new administration building, playground area, and updating the MPR (Completed January 2023)

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and one evening custodian are assigned to Abraham Lincoln Elementary School. The day custodian is responsible for:

- Lunch area setup/cleanup
- Office area cleaning
- Restroom cleaning
- Outside maintenance of buildings
- Trash removal from classrooms

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodian is responsible for:

- Cleaning desktops and whiteboards
- Restroom cleaning
- Vacuuming all rooms

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

Facilities Inspection

The district's maintenance department inspects Abraham Lincoln Elementary School on an annual basis in accordance with Education Code §17592.72(c)(1). Abraham Lincoln Elementary School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. The most recent school inspection took place on Thursday, October 26, 2023. No emergency repairs were needed and no unsafe conditions were found. During fiscal year 2023-24, all restrooms were fully functional and available for student use at the time of the inspection.

Rating Description

Exemplary: The school meets most or all standards of good repair. Deficiencies noted, if any, are not significant and/or impact a very small area of the school.

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, a full-time security agent, school site monitors, the counselor, and the administrator are strategically assigned to designated entrance areas and structured play activities. During recess, school site monitors supervise playground activity. School site monitors monitor lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, Lincoln staff are strategically placed to monitor dismissal when students are released from their classroom.

Abraham Lincoln Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office with a valid state issued identification to be scanned through the Raptor Security System and wear an identification sticker while on school grounds. They must then check out at the school office upon exit from the school site.

School Site Safety Plan

The Comprehensive School Site Safety Plan was developed for Abraham Lincoln Elementary School in collaboration with local agencies and the

district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. The school's most recent school safety plan will be reviewed, updated, and discussed with school staff by March 1, 2024.

Classroom Environment

Discipline & Climate for Learning

Abraham Lincoln Elementary School's discipline practices and behavior management strategies comply with approved board policies and are designed to create effective learning environments and minimize classroom disruptions. Multi-Tiered Systems of Support (MTSS) are used in the classroom for those students experiencing difficulty following school rules and demonstrating positive behavior. Disciplinary intervention is managed by the school administrator in an equitable and consistent manner based upon the age of the student and the incident that occurred.

Curriculum & Instruction

Staff Development

All training and curriculum development activities at Abraham Lincoln Elementary School revolve around the California State Content Standards and Frameworks. During the 2022-23 school year, Abraham Lincoln Elementary School held staff development training devoted to:

- Advancement Via Individual Determination (AVID)
- Early Literacy Instruction (i-Ready)
- Math Instruction
- Rigor and Relevance Frameworks
- Step Up to Writing
- Technology Training
- Universal Design for Learning (UDL)

Decisions concerning selection of staff development activities are performed by all staff using tools such as teacher input and data analysis to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Abraham Lincoln Elementary School supports ongoing professional growth throughout the year on minimum day Wednesdays. Teachers meet in grade level teams to conduct data analysis to identify areas of need. Instructional Materials

All textbooks used in the core curriculum at Abraham Lincoln Elementary School are aligned to the California Content Standards and Frameworks. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's eight-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, October 03, 2023, the Desert Sands Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 08/2023-2024 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2023-24 school year, Desert Sands Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

Expenditures Per Student

For the 2021-22 school year, Desert Sands Unified School District spent an average of \$17,444 of total general funds to educate each student (based on 2021-22 audited financial statements and in accordance with calculations defined in Education Code §41372).
