## Principal's Message

Welcome to Ronald Reagan Elementary School, home of the "Regal Eagles." Our school was dedicated October 11, 2006, with Congresswoman Mary Bono Mack in attendance. A beautiful letter written by Nancy Reagan was read at the ceremony encouraging all the children to live her late husband's dream of making this a better world. Reagan Elementary has quickly grown. This year, our diverse learning community includes approximately 830 students in grades TK/K through 5. In 2010, and again in 2020, the school received recognition as a California Distinguished School. While in 2009, 2012, 2014, and 2018, we were named a California Business for Education Excellence Honor Roll School. In 2016, the school was awarded the California Gold Ribbon School Seal as well as a California Model Physical Activity and Nutrition (PAN) School and Title I Achieving School. In 2017, we were one of five schools recognized in Riverside City as a Civic Learning School of Merit. For the past 7 years we have been both a Common Sense School and a Kindness Certified School. Most recently, in 2021 Reagan was named as an Imagine Nation School of Excellence, a Silver Level PBIS Implementation School, and in 2022 the California Department of Education recognized us as a California Pivotal Practice School.

Reagan is growing as a Dual Language Immersion (DLIS) school. This year we have two DLI classrooms in Grades K-4, and will add a grade each year until approximately 1/3 of our students are participating in that program becoming bi-literate in Spanish and English. Since 2020, Reagan has been designated as an AVID elementary school with all classrooms utilizing AVID instructional strategies and practices. With a motto of "learning today, leading tomorrow," Reagan Elementary embraces all of our students, supporting them in a nurturing and caring environment. Students are challenged daily to meet the rigorous California State Standards as they create their own brilliant futures. The entire learning community of Reagan Elementary recognizes each child's potential and contribution to our whole. Students attending Reagan are taught by a dynamic and experienced team of caring professionals, utilizing 21st century tools, including Chromebook computers for all students in grades 2 through 5, while those in grades K-1 have tablet learning centers. Our parents/guardians, volunteers, and community partners help provide support and interaction with our learners daily. Their regular involvement contributes to a wonderful joint venture between home, school and community, benefiting all the children at Reagan Elementary.

In addition to our regular rigorous academic program, students at Reagan benefit from a wide variety of extracurricular experiences and community partnerships that routinely enhance the quality, breadth, and depth of each child's educational experience. Unfortunately, the pandemic caused us to hit the "pause" button on many of our partnerships. Our amazing partnerships with the community include: Tools for Tomorrow - A Program in the Arts, Mini-Muster with PD Fire Department and Palm Desert Historical Society, McCallum Theatre Institute - Aesthetic Education Program, and Rotary International - EarlyAct Club (Student Government). We also enjoy community support from Smile Factory, Animal Samaritans, Kiwanis International, and our local Chamber and City governments. Our collective and total commitment to all of our children makes Ronald Reagan Elementary School an excellent community of learners, achieving together.

## School Description

Ronald Reagan Elementary School is located in the northeastern region of Palm Desert and serves students in grades transitional kindergarten through five following a traditional calendar. At the beginning of the 2022-23 school year, 834 students were enrolled, including 9.4% in special education, 18.5% qualifying for English Language Learner support, and 53.8% qualifying for free or reduced price lunch.

## Student Achievement

### Physical Fitness

In the spring of each year, Ronald Reagan Elementary School is required by the state to administer a physical fitness test to all students in grade five. The physical fitness test (PFT) for students in California schools is the FITNESSGRAM. The main goal of the test is to help students in starting life-long habits of regular physical activity.

The FITNESSGRAM has six parts, though California currently requires five parts be completed annually, that show a level of fitness that offer a degree of defense against diseases that come from inactivity. In the administration of the PFT during 2021-22 and 2022-23 school years, only participation results are required for these five fitness areas.

## California Assessment of Student Performance and Progress

The California Assessment of Student Performance and Progress (CAASPP) System includes the Smarter Balanced Summative Assessments (SBAC) for students in the general education population, and the California Alternate Assessments (CAAs) for students with the most significant cognitive disabilities. Only eligible students may participate in the administration of the CAAs. CAAs items are aligned with alternative achievement standards, which are linked with the Common Core State Standards (CCSS). CAASPP results are a measure of how well students are mastering California's standards in English language arts/literacy (ELA) and mathematics, and are given to grades three through eight and grade eleven. SBAC tests assess student performance in ELA/Literacy and mathematics utilizing computer-adaptive tests and performance tasks, and CAAs test items are aligned with alternative achievement standards which are linked with the Common Core State Standards (CCSS).

The CAASPP results shown in this report include overall results comparing the school, district and state scores as well as the school's overall score in each applicable subgroup. Results are shown only for subgroups with ten students or more taking the exam. For those categories that are blank in the tables, no students met subgroup criteria. ## School Facilities & Maintenance

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Ronald Reagan Elementary School's original facilities were built in 2004; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. In the last 12 months, the following campus repairs or improvements were completed:

- Upgrades to lighting system
- Installation of security cameras

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and three evening custodians (two full-time and one part-time) are assigned to Ronald Reagan Elementary School. The day custodian is responsible for:

- Cafeteria setup/cleanup
- Office area cleaning
- Restroom cleaning

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodian is responsible for:

- Classroom cleaning
- Cleaning desktops and whiteboards
- Office area cleaning
- Restroom cleaning

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

## Facilities Inspection

The district's maintenance department inspects Ronald Reagan Elementary School on an annual basis in accordance with Education Code §17592.72(c)(1). Ronald Reagan Elementary School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. The most recent school inspection took place on Tuesday, October 17, 2023. No emergency repairs were needed and no unsafe conditions were found. During fiscal year 2023-24, all restrooms were fully functional and available for student use at the time of the inspection.

## Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, the principal, assistant principal, and school site monitors are strategically assigned to designated entrance areas and the playground. During recess, teachers and school site monitors supervise playground activity. The principal, assistant principal, and school site monitors supervise lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, the principal, assistant principal, and school site monitors supervise student behavior to ensure a safe and orderly departure.

Ronald Reagan Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office with a valid state issued identification to be scanned through the Raptor Security System and wear an identification sticker while on school grounds. They must then check out at the school office upon exit from the school site.

## School Site Safety Plan

The Comprehensive School Site Safety Plan was developed for Ronald Reagan Elementary School in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival



and departure from school, sexual harassment policy, and dress code policy. The school's most recent school safety plan will be reviewed, updated, and discussed with school staff by March 1, 2024.

## Classroom Environment

### Discipline & Climate for Learning

Ronald Reagan Elementary School's discipline practices and behavior management strategies comply with approved board policies and are designed to create effective learning environments and minimize classroom disruptions. Multi-Tiered Systems of Support (MTSS) are used in the classroom for those students experiencing difficulty following school rules and demonstrating positive behavior. Disciplinary intervention is managed by the school administrator and counselor in an equitable and consistent manner based upon the age of the student and the incident that occurred.

### Staff Development

Ronald Reagan Elementary School supports ongoing professional growth throughout the year on minimum days. Teachers meet in grade level teams to conduct data analysis to identify areas of need. Teaching staff are provided the opportunity to participate in district-sponsored staff development workshops or training sessions as 1) a supplement to site-based staff development, 2) for reinforcement of or follow-up on previous training, or 3) follow-up training for newly implemented programs/curricula.

### Instructional Materials

All textbooks used in the core curriculum at Ronald Reagan Elementary School are aligned to the California Content Standards and Frameworks. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's eight-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, October 03, 2023, the Desert Sands Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 08/2023-2024 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARC's the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2023-24 school year, Desert Sands Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or

instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

### Expenditures Per Student

For the 2021-22 school year, Desert Sands Unified School District spent an average of \$17,444 of total general funds to educate each student (based on 2021-22 audited financial statements and in accordance with calculations defined in Education Code §41372).
