Principal's Message

John Glenn Middle School of International Studies is a state-of-the-art middle school that opened in September, 2001. The school houses more than 1,060 students in grades 6 through 8, with 48 classrooms, 4 science labs, a Robotics lab (a world level competition lab), a library/multi-media center, a multi-purpose room, cafeteria, locker rooms, open air gymnasium/pavilion, band room and athletic fields. John Glenn is part of a Magnet School Triad with Amelia Earhart Elementary School of International Studies and La Quinta High School. Amelia Earhart is authorized as an International Baccalaureate Primary Years Programme and La Quinta High School houses the International Baccalaureate Diploma Programme while John Glenn Middle School is authorized for the International Baccalaureate Middle Years Programme.

The International Baccalaureate Middle Years Programme (IBMYP) is a rigorous and holistic program that promotes interdisciplinary curriculum, inquire-based learning, high-level thinking skills, and an international focus. Since 2003, John Glenn has been an AVID School, and became a CA Distinguished School in 2009. In 2004, John Glenn Middle School was named a 'School to Watch' by the California League of Middle Schools in partnership with several other organizations. In 2005, John Glenn was named a National School to Watch. John Glenn Middle received these honors based on our outstanding academic programs, the presence of support systems that meet the academic and developmental needs of all students, and the commitment of our staff to continued and sustained professional development. John Glenn continues to be redesignated as a California and a National School to Watch. In 2022, John Glenn received a full redesignation for a sixth consecutive time. In 2015, John Glenn Middle School was named a California Gold Ribbon School, and an Honor Roll School. This award is given to schools that demonstrate high levels of student achievement, improvement over time & reduction in the achievement gap.

Students at John Glenn Middle School take up to eight subjects: Language & Literature, Individuals & Societies, Science, Mathematics, Arts, Physical & Health Education, Design, and Language Acquisition. The learning focus at John Glenn Middle School lies not only in the application of academic skills but also in the strong foundation built on cooperative relationships between school and home.

School Description

John Glenn Middle School is located in the western region of Indio and serves students in grades six through eight following a traditional calendar. At the beginning of the 2022-23 school year, 1045 students were enrolled, including 11.5% in special education, 10.6% qualifying for English Language Learner support, and 64.7% qualifying for free or reduced price lunch.

Student Achievement

Physical Fitness

In the spring of each year, John Glenn Middle School is required by the state to administer a physical fitness test to all students in grade seven. The physical fitness test (PFT) for students in California schools is the FITNESSGRAM. The main goal of the test is to help students in starting life-long habits of regular physical activity.

The FITNESSGRAM has six parts, though California currently requires five parts be completed annually, that show a level of fitness that offer a degree of defense against diseases that come from inactivity. The test results can be used by students, teachers, and parents. Comparative District and state results can be found at the CDE's web site www.cde.ca.gov/ta/tg/pf.

In the administration of the PFT during 2021-22 and 2022-23 school years, only participation results are required for these five fitness areas.

California Assessment of Student Performance and Progress

The California Assessment of Student Performance and Progress (CAASPP) System includes the Smarter Balanced Summative Assessments (SBAC) for students in the general education population, and the California Alternate Assessments (CAAs) for students with the most significant cognitive disabilities. Only eligible students may participate in the administration of the CAAs. CAAs

items are aligned with alternative achievement standards, which are linked with the Common Core State Standards (CCSS). CAASPP results are a measure of how well students are mastering California's standards in English language arts/literacy (ELA) and mathematics, and are given to grades three through eight and grade eleven. SBAC tests assess student performance in ELA/Literacy and mathematics utilizing computer-adaptive tests and performance tasks, and CAAs test items are aligned with alternative achievement standards which are linked with the Common Core State Standards (CCSS).

The CAASPP results shown in this report include overall results comparing the school, district and state scores as well as the school's overall score in each applicable subgroup. Results are shown only for subgroups with ten students or more taking the exam. For those categories that are blank in the tables, no students met subgroup criteria. Local Control Accountability Plan (LCAP)

School Facilities & Maintenance

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. John Glenn Middle School's original facilities were built in 2001; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. In the last 12 months, installation of additional security cameras was completed.

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and two evening custodians are assigned to John Glenn Middle School. The day custodian is responsible for:

- Cafeteria setup/cleanup
- Groundskeeping
- Restroom cleaning

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodians are responsible for:

- Classroom cleaning
- Office area cleaning
- Restroom cleaning

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

Facilities Inspection

The district's maintenance department inspects John Glenn Middle School on an annual basis in accordance with Education Code §17592.72(c)(1). John Glenn Middle School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. The most recent school inspection took place on Monday, October 23, 2023. No emergency repairs were needed and no unsafe conditions were found. During fiscal year 2023-24, all restrooms were fully functional and available for student use at the time of the inspection.

Rating Description

Exemplary: The school meets most or all standards of good repair. Deficiencies noted, if any, are not significant and/or impact a very small area of the school.

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, administrators, teachers, school site monitors, and security agents patrol the campus, entrance areas, and designated common areas. Administrators, security agents, school site monitors, coaches and counselors monitor lunch time activity in the cafeteria and common student activity areas. At the end of the day when students are dismissed, administrators, teachers, and school site monitors monitor student behavior and ensure students either leave campus or travel to after-school activities in a safe and orderly manner.

John Glenn Middle School is a closed campus. During school hours, all visitors must sign in at the school's office with a valid state issued identification to be scanned through the Raptor Security System and wear an identification sticker while on school grounds. They must then check out at the school office upon exit from the school site.

School Site Safety Plan

The Comprehensive School Site Safety Plan was developed for John Glenn Middle School in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting

procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. The school's most recent school safety plan will be reviewed, updated, and discussed with school staff by March 1, 2024.

Classroom Environment

Discipline & Climate for Learning

John Glenn Middle School's discipline practices and behavior management strategies comply with approved board policies and are designed to create effective learning environments and minimize classroom disruptions. Progressive discipline and proactive measures are employed in the classroom for those students experiencing difficulty following school rules and demonstrating positive behavior. Disciplinary intervention is managed by school administrators in a fair and consistent manner based upon the nature of each situation.

Staff Development

All training and curriculum development activities at John Glenn Middle School revolve around the California State Content Standards and Frameworks. During the 2022-23 school year, John Glenn Middle School held staff development training devoted to:

Decisions concerning selection of staff development activities are performed by all staff using tools such as teacher input and data analysis to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. John Glenn Middle School supports ongoing professional growth throughout the year on minimum days. Teachers meet in both grade level and department level teams to conduct data analysis to identify areas of need. Teaching staff are provided the opportunity to participate in district-sponsored staff development workshops or training sessions as 1) a supplement to site-based staff development, 2) for reinforcement of or follow-up on previous training, or 3) follow-up training for newly implemented programs/curricula.

Instructional Materials

All textbooks used in the core curriculum at John Glenn Middle School are aligned to the California Content Standards and Frameworks. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's eight-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, October 03, 2023, the Desert Sands Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 08/2023-2024 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2023-24 school year, Desert Sands Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

Expenditures Per Student

For the 2021-22 school year, Desert Sands Unified School District spent an average of \$17,444 of total general funds to educate each student (based on 2021-22 audited financial statements and in accordance with calculations defined in Education Code §41372).
